

## What is RC&D?

East Central Colorado RC&D (ECCRC&D) is a non profit rural development organization that promotes community, economic and natural resource development in the region. The purpose of RC&D is to improve general levels of economic activity and to enhance the environment and standard of living in all communities through promotion of conservation, development and utilization of natural resources, and improve the quality of life in rural communities. The RC&D is organized around some core concepts to insure locally led action. These include:

- ⇒ **Sharing the value of grass-roots involvement in decision-making**
- ⇒ **Sharing the value of public private partnerships**
- ⇒ **Leveraging governmental funds with private funds to accomplish goals**
- ⇒ **Working towards community sustainability**
- ⇒ **Achieving a balance between rural economic development and natural resource protection**
- ⇒ **Bringing Governmental Agencies and others together to focus on common problems**

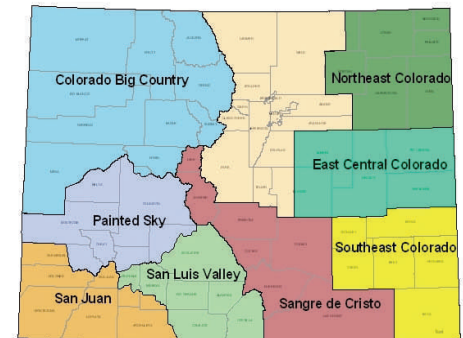

## EXAMPLES OF ACHIEVEMENTS

Each RC&D council has the opportunity to propose and develop projects unique to their own area. There are no top-down programs/projects that they must do. Partnerships with other organizations, and agencies are vital to the functioning of RC&D. Here are just a few of the projects we worked on in the past:

- ◆ **Historical Preservation:** *Inventoried 75 historical buildings in the area and listed several on the Colorado State Historical Register. Grants for assessment & restoration of registered buildings. Examples are the Drennan School, Empress Theater, and the Hedlund House Museum.*
- ◆ **Community Improvement:** *In partnership with local community groups helped to replace the playground equipment in Hugo, Seibert/High Plains schools and Develop the Rush Ball field.*
- ◆ **Noxious Weed Educational Program:** *Wrote two grants in partnership with NRCS, CSU Cooperative Extension, the Hi-Plains and Prairie CD to obtain funding to do a weed survey in Lincoln County. Weed workshops were held.*
- ◆ **Recycling:** *Initiated the original Eastern Colorado Recycling program. Now South-east/East Central Recycling. The program currently serves 42 communities in 12 counties. Largest Rural Recycling Program in the Nation.*
- ◆ **Area Reorganization:** *ECC RC&D worked with NEC RC&D to move Washington county to the NEC RC&D service region.*
- ◆ **Renewable Energy:** *Strategic plan for east central counties, assisted with "Wind for Schools".*

- ◆ **Council Development:** *Cooperatively sponsored a two day Council Member Training, in 2001, 2002, 2003 & 2004. Continue education at each council meeting*
- ◆ **Economic Development Committees:** *Working with groups such as Hugo Improvement Partnership, Lincoln County Economic Development, and Flagler Community Development to improve the quality of life in these areas.*
- ◆ **Water Management:** *Assisted the Town of Burlington, Kit Carson County, Kyle Railroad, and East Central Council of Gov. to create the 15th Street storm water drainage system to improve water drainage. Working with two other communities on water drainage issues.*
- ◆ **Community Self Renewal:** *3 year project funded by El Pomar Foundation in which 6 communities assessed their needs, planned projects to benefit their communities, then did fundraising for their projects*  
*Burlington Area 2020—Park/Lifeline \$90,000*  
*Stratton 2000—Pool/Job \$100,000*  
*Seibert Action—Comm. Bldg & Store \$300,000*  
*Hugo Improvement— Depot & Trail \$20,000*  
*Kit Carson R.D.— Golf/Pool Hall/Sign \$50,000*  
*Cheyenne Wells 21—Housing/Park \$15,000*
- ◆ **Conservation Projects:** *Assisted seven conservation districts obtain \$127,000 in matching funds for local conservation cost-share projects with Ag producers.*
